As an example, if you were born in Alaska, you would write to:

Because fees will vary from state to state, you may call the appropriate state for that information. The phone numbers are listed below or you may dial (area code) 555-1212 and ask for the state's Department of Vital Statistics phone number.

As a note, we have seen fees range from \$2.00 to as high as \$20.00.
